OFFICE REPORT

The Misc. application no. 23 of 2019 and 2432 of 2018 with other connected M.A. were disposed of with directions vide Hon'ble Court's order dated 08.3.2019 & 24.9.2018 respectively and Civil Appeal No. 4772 of 2018 alongwith other connected matters were disposed of with directions vide Judgment dated 03.05.2018. The copies of the Judgment & record of proceeding are annexed in their respective contempt petitions paper-books.

It is submitted that Mrs. Sarla Chandra, Advocate has filed Contempt Petitions against the alleged contemnors/respondents for wilful and gross disobedience of the orders dated 08.3.2019 and 03.5.2018 and Contempt Petitions have been registered as Contempt Petition Nos. 764, 774, 773, 772 & 775 OF 2019 in C.A. Nos. 4772, 4776, 4777, 4778 and 4774 of 2018 respectively.

Counsel has also given a letter regarding the non availability of the residential address of the alleged contemnors/respondents, however the official address is mentioned in the memo of parties. Copy of the letter dated 10.7.2019 is annexed in contempt petitions paper-books.

It is further submitted that Civil Appeals paper-books have been weeded out after due preservation as per rules and counsel for the petitioner have filed fresh paper-books of the same.

It is lastly submitted that Mrs. Sarla Chandra, Advocate has on 17.7.2019 filed application for permission to file additional documents alongwith additional documents in Contempt Petition @ Nos. 764 & 774 of 2019 and the said applications have been verified as I.A. Nos. 104332 & 104334 of 2019. Copies of the applications have been placed with contempt petitions paper-books.

The Contempt Petitions alongwith applications in the matters above-mentioned are listed before the Hon'ble Court.
