CONTEMPT PETITION (C) NOS. 764, 774, 773, 772 & 775 OF 2019

The matters above-mentioned were listed before Hon'ble Court on 22.07.2019, when the Court was pleased to pass the following order:

"Issue notice.

The personal presence of the alleged contemnors/respondents is dispensed with for the time being."

According, returnable common notice was issued to both the alleged contemnors/respondents through registered A.D. post. Mrs. Madhumita Bhattacharjee, Advocate has on 26.8.2019 filed Vakalatnama/Appearance on behalf of alleged contemnor no. 1 (Common in all the matters) in Contempt Petition (C) No. 764/2019, but she has not filed counter affidavit, so far. Mr.

Kunal Chatterjee, Advocate has on 30.8.2019 filed Vakalatnama/Appearance and separate counter affidavit on behalf of alleged contemnor no. 2 in all the contempt petitions. Copies of the counter affidavits have been placed with contempt petitions paper-books.

It is submitted that Mrs. Sarla Chandra, Advocate has on 31.7.2019 filed application for permission to file additional documents alongwith additional documents in contempt petition (C) No. 773/2019 and the said application has been verified as I.A. No. 113080/2019. Copy of the application has been placed with contempt petition paper-books.

Service of notice is complete.

**CONTEMPT PETITION (C) NO. 966 OF 2019 IN CIVIL APPEAL NO. 4773 OF 2018**

The Misc. application no. 23 of 2019 and 2432 of 2018 with other connected M.A. were disposed of with directions vide Hon'ble Court's order dated 08.3.2019 & 24.9.2018 respectively and Civil Appeal No. 4773 of 2018 alongwith other connected matters were disposed of with directions vide Judgment dated 03.05.2018. The copies of the Judgment & record of proceeding are annexed in contempt petition paper-books.

It is submitted that Mrs. Sarla Chandra, Advocate has filed Contempt Petition against the alleged contemnors/respondents for wilful and gross disobedience of the orders dated 08.3.2019 and Contempt Petition has been registered as Contempt Petition(C) No. 966 of 2019 in C.A. No. 4773 of 2018.

It is further submitted that Civil Appeals paper-books have been weeded out after due preservation as per rules and counsel for the petitioner have filed fresh paper-books of the same.

The Contempt Petitions alongwith applications in the matters above-mentioned are listed before the Hon'ble Court.
