No. 4772 of 2018 and he has also filed a letter dated 24.9.2019 stating therein that vakalatnama on behalf of total applicant nos. 660 had already been filed before this Hon'ble Court on 01.12.2018 in I.A.No. 173930 of 2018 in SLP(C) Dairy No. 43889 of 2018. The application has been verified as I.A. No. 148622/2019 and copy of the same is being circulated herewith.

It is lastly submitted that Mrs. Sarla Chandra, Advocate has on 25.9.2019 filed applications for permission to file additional documents alongwith additional documents in contempt petition (C) Nos. 772 & 773 of 2019 in C.A. Nos. 4778 & 4777 of 2018. The said applications have been verified as I.A. Nos. 148997 & 149000 of 2019 and copies of the same are being circulated herewith.
